**ORDINANCE PERTAINING TO THE  
NAMING OF STREETS IN THE TOWN OF STALLINGS**

**WHEREAS**, pursuant to North Carolina General Statute §160A-296, the Town of Stallings may name or rename any public street within the corporate limits of the Town and may assign street numbers for use on such streets; and

**WHEREAS**, the North Carolina Department of Transportation has created the need to provide names for new streets, seven (7) total, located within the corporate limits of the Town of Stallings as a result of the Monroe Expressway construction; and

**WHEREAS**, the Stallings Town Council selected the names during an open meeting on November 13, 2017;

**NOW, THEREFORE, BE IT ORDAINED THAT** the following street names are hereby established within the Town limits of Stallings:

- SRRT1 - Guion Lane
- SRLT 3 - Stallings Commerce Drive
- SR16 - Sweet Birch Drive
- Y111 - Marie Garris Drive
- Y111A - Lodging Way
- Y114 - Richard Baker Drive
- SR2 - Union West Extension
