Police Update

- We (along with Union County) have had a rash of vehicle break-ins recently. The case is being worked however no suspects at this time.
- On September 19, a serious injury crash occurred on Hwy 74. A disabled vehicle was in the roadway and was struck in the rear by a vehicle traveling at approximately 60 mph. The seriousness of the accident was caused when the front passenger was ejected from the vehicle. She is in critical condition at this time.
- Det Sgt Cranford and Captain Harrington traveled to Arkansas to retrieve a suspect in a Sexual Assault case.
- The PD Special Olympics Car Show was held and was a great success. Over \$4000 was raised for NC Special Olympics. Sgt. Ben Davis is to be commended for his continued hard work for this very worthy cause.

Idlewild Rd Widening

Lawyers Rd./Stevens Mill Rd Intersection

- Union County has advertised an RFQ for developing conceptual designs/cost estimates for six intersections from the Critical Intersection Analysis.
- This intersection is one of the six

Chestnut - Weddington Rd Roundabout

- NCDOT is working with developer to integrate 4th leg into the design.
- NCDOT will enter into an agreement with the developer for design and construction reimbursement for the infrastructure associated with the development.
- Moving forward with the current schedule. R/W 2019 Const 2020.

Lawyers - Emerald Lake Roundabout

- R/W 2020 Const 2021.
- Intersection will be closed during construction (summer while school is out).
- Country Woods and Emerald Lake have alternate access points for ingress/egress during construction.
- During the R/W acquisition phase, NCDOT will send out a mailer to vicinity residents outlining the nature of the project.

Public Works Update

- Several repairs had to be made to the FACP (25 trouble codes) due to a lightning strike.
- AC unit in evidence building was leaking. We just had to clear drain line and it's working fine now.
- Installed missing stop bar on pavement at 4 way stop on Divide Dr. near golf course.
- HVAC unit 4 was freezing up. Unit was found to be overcharged. TXV was replaced under warranty. Additional parts were needed to complete repair and unit was charged to correct level.
- Had to replace HVAC AHU bypass actuator on all units. They were sticking and not working properly.
- Working with engineering to come up with a more cost effective way to make sidewalk repairs. We have a quote from Precision Sidewalk and once me and Chris have a chance to review Fairhaven subdivision may be our test site for this new process.
- Parks and Rec had their final concert event for the summer, and from the PWX side it seemed to be a success. We had no major issues the setup and tear down went well. Largest attendance for the concert series.

Parks & Recreation Update

Splash Pad Update:

Union County finally issued the required permits and W.P. Law is scheduled to begin new equipment installation on 9/18/19.

Greenway Design:

The wetland delineation is complete for the Vickey/Blair Mill greenway. They are awaiting final surveying results to complete the preliminary design. At that point, we will schedule a community meeting with Vickery residents and staff planning sessions with NCDOT.

We included a door knocker craft for kids to color before the movie began. I would say there were 50-60 people there in attendance.

Friday, September 6th

The last concert in the A Tribute to Summer Concert Series hosted On the Border – the ULTIMATE Eagles Tribute band. Concert goers began arriving at 3:45 to get a

seat for the show. A rough estimate of 250-300 people were in attendance at the show. Hog n Dog, JessKakes, Velo Pops, Cabarrus Brewing Co., and Red Clay Ciderworks were all vendors at the event. We are excited to have another concert series next summer.

NC and National Recreation & Parks Conferences:

Parks and Recreation staff are attending the joint NC/SC Conference and the National Conference this month to receive training and guidance on the newest industry trends, safety practices, and innovative services to implement here in Stallings.

Park Maintenance Updates:

Due to storm damages in previous months, 2 trees are being removed at the Blair Mill property. We have an arborist consulting on a tree in Stallings Park on 9/19/19 to see what our next course of action will be for the tree directly next to Shelter A.

Human Resources Update

- Mary McCall started on July 24th she is our Accounting Technician working at the front desk, please welcome Mary to the Administrative staff
- Kim Jones is now in her new position as the Police Administrative Services Coordinator, Kim is doing a wonderful job in the Police Department

Finance

- Finance Report in 9/23/19 Council packet.
- FY2019 Audit Potter & Company began the FY2019 on Aug. 19th and completed most of their field work. Expect the draft report by Sept 30 so we can begin compiling the CAFR.
- Completed and filed the ESAC Asset Forfeiture report for FY2019 and are now in compliance with the program.
- Completed and files the Powell Bill Expenditure Report for FY2019.
- Responded to 4 public requests for information since the beginning of FY2020
- Received reimbursement check from NCDOT for Potter Road/Pleasant Plains in the amount of \$1.2M for right of way acquisition costs spent to date.
 - Expect to receive an additional \$1.6M in construction costs once the intersection is complete.
